Payments must be submitted within 30 days from registration day. After March 16, 2024 registration, all payments must be submitted on the day of registration. Cancellations & Refunds: To receive a refund for weekly fees paid for camp, cancellations must be received in writing to the school administration at least 30 days prior to attending the first week of camp. Cancellations received within 3 weeks prior to the camp will receive a 50% refund. Cancellations received within 2 weeks of the camp are not eligible for a refund

## 2024 Summer Camp Tuition Agreement

All families wishing to enroll their child(ren) must read the tuition policies below and sign at the Bottom in agreement with the TSCS financial obligations and policies.

All tuition charges will be billed through Brightwheel and statements can be accessed through your personal Brightwheel account. Families can choose to directly link their bank account information for a direct transfer through Brightwheel. We accept payment in the form of direct transfer, or cash/check.

The Sent Christian School ("School") and the undersigned parents ("Parents"), by entering into this tuition agreement to enroll their child listed below ("Student") for the 2024 Summer camp, executed by the parents on the signed date below, agree as follows:

- 1. **Consent:** This agreement is entered into with mutual consent of Parents and the School.
- 2. **Enrollment deposit:** The School requires a \$100 non-refundable enrollment deposit ("Deposit") to reserve a spot for the student in the 2024 Summer Camp. The Deposit is not credited towards payment of tuition.
- 3. **Tuition and charges:** Parents agree to pay the full amount for tuition and fees. The tuition and fees may be modified if Parents receive tuition assistance from the school. Any such modifications are only effective if set forth in a written amendment of this agreement, signed by Parents and the School. Payments must be submitted within 30 days from registration day or before March 15, 2024. After March 16, 2024 registration, all payments must be submitted on the day of registration. If the payment is not received by March 15, 2024 for early enrollment, all student's registration will be automatically canceled and you would need to reapply and regular tuition will apply.
  - There will be no credit or refund throughout the 5 weeks of summer camp, regardless of holidays, student absences, or school closures due to inclement weather, natural disaster, or an "Act of God," which prevents school operations.
- **4. Additional fees:** Parents agree that additional fees for school services may be charged during the 2024 summer camp. Additional fees are due when charged and will be billed and payable through Brightwheel or paid directly to the school or a third party designated by the school.
- 5. Payment obligation: Parents have an individual and joint obligation to pay all tuition and fees under this agreement. Failure to pay the tuition by the due date will result in the cancellation of the camp registration. Parents' failure to pay any amount when due pursuant to the terms of this Agreement, may, at the School's sole discretion, result in the suspension or dismissal of the Student from the School. Parents shall pay any costs and attorney's fees the School incurs in collection of Parents' outstanding balance.
- 6. **Cancellations & Refunds:** To receive a refund for weekly fees paid for camp, cancellations must be received in writing to the school administration at least 30 days prior to attending the first week of camp. Cancellations received within 3 weeks prior to the camp will receive a 50% refund. Cancellations received within 2 weeks of the camp are not eligible for a refund.
  - TSCS canceled session A full credit and/or refund will be issued in situations where the school cancels a camp session.
  - Weather related closings No credits or refunds will be issued should weather cause closings.

- Absentee and Sick Camper Please see ill/sick camper policy in the parent manual. There is no reduction of fees if a child is absent from camp, including illness.
- <u>Damaged Property</u> Replacement costs of damaged or broken KCPC property, either accidentally or deliberately, is the responsibility of the parent/guardian; this includes any property associated with camp operations, locations or vehicles.
- <u>Behavioral Issues and Suspensions</u> If a student is suspended from camp, there will be no refund of camp fees. Students may be dismissed from the program without notice if their behavior is consistently disruptive or if their behavior threatens the health and safety of their or the safety of other campers or staff. Behavior guidelines apply to a student's parents, guardians or caregiver and a camper may be dismissed from camp for their actions.
